One-Day Beer License**

**APPLICATION FEE:** Each applicant at the time of filing an application for a permit as provided hereunder shall pay a **nonrefundable** application fee of two hundred fifty dollar (\$250.00) to defray the cost of investigation of such application and no such application shall be considered until said fee has been paid to the City of Brownsville. (See Title 8, Chapter 2, Section 8-208 of the Brownsville Municipal Code).

Please list three (3) references on the application. To make sure that your application is processed in a timely manner, we recommend that you list references that will provide a quick response. Please provide an accurate and complete address for each reference that is listed on the application.

Please fill the application out in it's entirely, giving exact descriptions and details whenever possible.

Please write your driver's license number on the application and return the completed document to City Hall.

You will be notified when your application is ready to be presented before the Beer Board for consideration. Please provide a phone number where you can be reached between the hours of 8:00 am and 4:30 pm, Monday through Friday. You **cannot** sell beer in the City of Brownsville until the Beer Board has approved your application and your permit has been issued.

**BEER PERMITS ARE NOT TRANSFERABLE.** A permit is only for the owner to whom it is issued and cannot be transferred to another owner.
